## **FOREWORD**

This guide has been prepared in order to inform the candidates who will apply for undergraduate programs from abroad about the application, placement and registration procedures to study at Izmir Bakırçay University in the 2025-2026 academic year.

The rules and information in the guide have been prepared in accordance with the Criteria for the Admission of Students from Abroad and the Principles Regarding the Admission of Students from Abroad by the Council of Higher Education (YÖK) in the relevant article of the Law No. 6287, the Application, Admission and Registration Directive for International Students of Izmir Bakırçay University and the Administrative Board and Senate of Izmir Bakırçay University. The guide can be updated if necessary by the decisions of the legislative, executive and judicial organs, the Council of Higher Education (YÖK), Izmir Bakırçay University Administrative Board and Izmir Bakırçay University Senate, which may enter into force after the publication date of the guide. In cases not specified in the guide, action is taken in line with the decisions to be taken by our University Senate.

In order to follow the processes during the announcement and registration phase, the candidates should refer to the relevant announcements to be published on the official website of our University, since updates may be made in the guide by our University.

Applicants are deemed to have accepted all the regulations in this guide.

# **1. PROSPECTIVE STUDENTS**

## **1.1. Candidates whose applications to be accepted**

Those who are in their last year of high school or are high school graduates and are:

- A. Foreign nationals or,
- B. Those who were born Turkish Citizens and were granted permission to give up Turkish citizenship from the Ministry of Interior or are their minor children and registered in the certificate of renunciation and have the Certificate to Exercise Rights granted under the Turkish Citizenship Law (according to Article 7 of Turkish Citizenship Law 5901, “A child born to a married Turkish father or mother, whether in Türkiye or abroad, is a Turkish citizen.”)
- C. Foreign citizens who earned later Turkish Citizenship and therefore have dual citizenship,
- D.
  - a. Turkish citizens who began secondary education prior to February 1st, 2013 and have completed the last three years of their secondary education (high school) in a foreign country other than TRNC (including those who have completed all of their secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than TRNC.),
  - b. Turkish citizens who began secondary education abroad following February 1st, 2013 and completed all of their secondary education (high school) in a foreign country other than TRNC (including those who have completed all of their secondary education in Turkish schools opened by the Ministry of National Education in a foreign country other than TRNC.),
- E. TRNC nationals who reside in TRNC and have completed secondary education (high school) in TRNC and have GCE AL exam results and those who registered for high school in foreign countries between 2005 and 2010 and have GCE AL exam results.

## **1.2. Candidates whose application will not be accepted:**

- A. Turkish citizens who completed all secondary education (high school) in Türkiye or TRNC,
- B. TRNC nationals (except those who completed all secondary education (high school) in TRNC high schools and have a GCE AL exam results or those who registered to high schools in foreign countries between 2005 and 2010 and have GCE AL exam results,
- C. Dual citizens who are Turkish by birth as specified under article 1.1. (B) (excluding those who have completed all of their secondary education in a foreign country other than the TRNC, and those who have completed all of their secondary education at Turkish schools in a foreign country other than the TRNC),
- D. Individuals with dual citizenship one of which is TRNC citizenship (excluding those who have completed all secondary education in TRNC and have GCE AL scores, and those who have completed all secondary education in other countries between 2005 and 2010 and have GCE AL scores),
- E. Those who hold a Turkish citizenship or a dual citizenship including Turkish citizenship by birth as stated in Article 1.1. (B) and who have completed secondary education at schools within embassies in Türkiye or foreign high schools within Türkiye.

## 5. APPLICATION AND REGISTRATION

### 5.1. General Information on Application and Registration

- Applications will be made on the application page between **01 July 2025 -11 July 2025**. Please [click here](#) to access the application page. (The application page will be active during the application dates.) [Click here](#) to access the step-by-step application screen where the application procedures are explained.
- Personal information must be entered exactly as it appears in the applicant's passport without any changes. Applicants are fully responsible for errors while filling in the application form.
- Exam results and achievement certificates which do not have a document verification system are not taken into consideration.
- The photograph to be uploaded to the application form must be taken within the last six months in a way that allows the candidate to be easily recognized.
- **Applicants may apply to only one degree program. If a candidate submits multiple applications, their first application will be considered valid.**
- Turkish proficiency preparatory education is carried out in accordance with our University's DİLMER Implementation Directive. All students who are placed in our University with the status of foreign students must certify that they have Turkish language proficiency at the C1 level in order to start their courses in the departments they are enrolled in. For information and pricing details about the Turkish Proficiency Exam to be held by our university, [click here](#). As for the Turkish Proficiency Certificate, Yunus Emre Institute documents obtained within the last two years as of the registration date are also valid.
- Students enrolled in programs where foreign language preparatory class is compulsory are subject to our University's School of Foreign Languages Education-Training and Examination Directive in preparatory education. [Click here](#) for the directory.
- The registration of those, who have submitted falsified, fake, incomplete and wrong documents during the application, placement and registration process is cancelled even their final registration has been completed.
- In line with the decision taken by our University no refund of tuition fee will be made.

### 5.2. Documents Required for Application

During registration, the originals of the documents uploaded to the application system and other documents listed below will be requested from the candidates. Documents listed below should be uploaded to the system.

- a) For candidates who have completed their secondary education outside of the Republic of Türkiye, the equivalency certificate to be obtained from the provincial national education directorates in Türkiye and from the education consultancy/attachment offices abroad,
- b) A copy of the original high school diploma approved by the notary public or the Embassy / Consulate of the Republic of Türkiye (Candidates who are in the last year of high school will bring a certified document confirming that they can graduate.)
- c) A copy of the original transcript / transcript translated into Turkish approved by a notary public or the Embassy / Consulate of the Republic of Türkiye,



- ç) Original passport or identity card obtained from official authorities. (Students with Turkish citizenship and who have completed their high school education abroad are required to submit The Country Entry/Exit Document from e-Government with a barcode indicating that they have completed all their high school education in the form of formal education abroad.)
- d) Photograph (should be in the form of a passport photo)
- e) TR-YÖS result document issued by the OSYM Presidency, has a verification code accepted by our University Senate or SAT1 or GCE-AL (TRNC nationals only) exam result documents specified in this guide.
- f) The original of the GCE AL exam result document of the TRNC national candidates who have completed their entire secondary education in TRNC high schools.
- g) Foreign Language Proficiency Certificates (if any)
- h) Turkish Proficiency Certificates (if any)

### **5.3. Documents Required for Registration**

The registration will be carried out by the Department of Student Affairs.

The documents required for registration for international students who have been accepted to undergraduate programs at our University are listed below:

- a) Bank receipt of tuition fee payment,
- b) Secondary School Diploma (both the original version and Turkish translation approved by Notary or Turkish Embassy/Consulate abroad) (for those who have recently graduated and do not have a diploma: a certified document confirming that they have graduated),
- c) Equivalency Certificate of the Diploma given by the Turkish Ministry of Education or official Turkish Representatives abroad,
- d) Transcripts, showing the names of courses and grades received for each course, approved by the principle of the applicant's high school, and a Turkish translation approved by a Notary or Turkish Embassy/Consulate abroad,
- e) The original documents of Exam Result uploaded to the system,
- f) Original passport or identity card obtained from official authorities (Students with Turkish citizenship and who have completed their high school education abroad are required to submit The Country Entry/Exit Document from e-Government with a barcode indicating that they have completed all their high school education in the form of formal education abroad.),
- g) A copy of Student Visa obtained through Turkish Representatives abroad,
- h) If available, a Foreign Language Certificate and/or Turkish Proficiency Certificate accepted by our University,
- i) The original of the GCE AL exam result document of the TRNC national candidates who have completed their entire secondary education in TRNC high schools,
- j) 4 photographs.

## 6. EVALUATION OF APPLICATIONS

### 6.1. Exams, Diplomas and Minimum Söre Accepted

The types of international exams and diplomas that will be taken into consideration by our university during the application process of international students, the content of the exams, the duration of admission, the maximum and minimum scores, and the assessment methods for the 2025-2026 Academic Year are presented below.

According to the decision of our University Senate international applicants are required to submit SAT1 or TR-YÖS test scores as part of the application process.

In accordance with Article 6 of our University's Application, Admission and Registration Directive for International Students, candidates of TRNC nationality will be able to apply only with the GCE-A Level Exam. TR-YÖS and SAT exam requirements will not be required for these candidates.

<b>Examinations Recognized by Izmir Bakircay University for International Student Applications for the 2025–2026 Academic Year</b>	
<b>EXAM</b>	<b>STATEMENT</b>
<b>Scholastic Assessment Test (SAT1)</b>	Applicants must have obtained a minimum total score of 960 out of 1600 on the SAT Reasoning Test (SAT1), calculated from the "Math" and "Evidence-Based Reading and Writing" sections (referred to as "Critical Reading" in the older version of the SAT). The SAT exam, which is administered as a university entrance examination, is recognized by our university for a period of 2 years. This 2-year period begins on the date the test results are announced and only <b>scores</b> obtained in the <b>2</b> years leading up to the <b>application deadline</b> will be considered. The tables outlining the criteria for the acceptance of SAT1 scores are provided below.
<b>GCE AL Exam</b>	Only those who are citizens of the Turkish Republic of Northern Cyprus (TRNC), reside in the TRNC, and have completed their secondary education (high school) in the TRNC and possess GCE AL exam results, as well as those who enrolled in and studied at colleges or high schools in other countries between 2005 and 2010 and possess or will obtain GCE AL exam results, will have their GCE AL certificates accepted. There is no time limitation regarding the validity of the GCE AL exam. The tables outlining the criteria for the acceptance of GCE AL scores are provided below.

<b>Türkiye Exam for International Student Admission (TR-YÖS)</b>	The TR-YÖS Exam is a centralized examination administered by ÖSYM (Assessment, Selection and Placement Center) across designated provinces in Turkey and in selected international representative countries. The exam is scored on a scale ranging from 100 to 500. The validity period of the TR-YÖS exam is two (2) years from the date of the examination. The validity period of the TR-YÖS exam is 2 years retrospectively from the application deadline. The tables outlining the criteria for the acceptance of TR-YÖS scores are provided below.

## **6.2. Conversion of Scores and Placement Process**

**Evaluation and placement processes will be carried out as follows:**

1. The scores of the internationally recognized SAT-1, TR-YÖS, and GCE-AL exams, determined by the commission, are formulated and converted over 100 and the applicants application score will be determined accordingly.
2. The application scores out of 100 will be ranked from the highest score and a placement list will be created within the quotas determined by the senate. (The country quota limit determined by the Presidency of Council of Higher Education and the Senate of our University will be taken into account when creating these evaluation rubrics.)
3. After the placement of the candidates on the Main List, if there are still vacant quotas, the placement of the substitute students will be executed by starting from the candidate with the highest score in the substitute list, and the placement of the substitute students will continue until the quotas are filled during the placement periods.
4. In case of an equality in the scores of the applicants;
  - a) Priority is given to the student with a higher overall grade average, taking into account the High School Diploma grade average of the candidate student.
  - b) If the tie continues, priority is given to the younger candidate, and placement is made accordingly.
